### **Future Global Conferences**

- Africa ICAs are recommending Zimbabwe for a 2024 global conference
- Global Conferences Team has been on hiatus as new dynamics of virtual and in-person dynamics are being created.
- Asia Pacific has seen itself prototyping what a global conference could look like.
- Next steps: Reconvene Global Conferences Team to consider and make recommendations to ICAI Board; then Board takes to General Assembly. Next GA in April.
- Rehearse history of global meetings: 1984 IERD, Denver, Japan, Nepal. Rehearse values for holding in person or virtually (financing; participation ICA, outside ICA; frequency; role of quarterly GAs in relation to global meetings; etc.). What is emerging? What is need for an inperson conference? How are we creating a global environment? How are our images changing?
